Schurmer & Drane recovered **\$2,000,000.00** for a family who lost their daughter when she drowned at a local lake. We alleged that the owner of the lake and the entity that controlled all of the ranger services and maintenance of the land were negligent. Specifically, that in the area where the young girl drowned, the lake floor suddenly dropped off from 1-2 feet in depth to over 10 feet in depth. Even though the defendants held this location out as a safe place to swim it was impossible to tell from the shore that this steep drop off existed. The young girl was wading in knee to waist deep water when suddenly she stepped off of the ledge into deeper water and immediately drowned. Defendants did not place any warning signs of any sort to alert campers of this dangerous condition.

Schurmer & Drane recovered **\$170,000.00** for a 53 year-old woman who suffered a Galleazi fracture to her forearm when she fell in a parking lot. We alleged that the cracks in the parking lot resulted in a dangerous condition that caused the fall. The defendant claimed that the parking lot was not dangerous and the cracks were not sufficiently large to cause anyone to fall. The defense also claimed that her injury was not severe and had completely healed. Schurmer & Drane recovered **\$625,000.00** for a 39 year-old woman who suffered a low back injury in a bus accident. In the time frame after the accident the injury to her back did not seem to be as serious as it ultimately turned out to be. The client finally had surgery to her back almost three years after the accident. Because of the delay in surgical treatment and a number of other issues the defense hotly disputed the nature and extent of her injuries. The matter ultimately settled right before trial when the defendant dramatically increased the offer to settle.

Schurmer & Drane recovered **\$700,000.00** for a 49 year-old gentleman who was rear-ended while driving an 18 wheel tractortrailer on the freeway. The client was initially treated through the worker's compensation system and within a few months the worker's compensation physicians stated that he had completely healed and should go back to work. After consulting with Schurmer & Drane and seeing different orthopedic specialists it was determined that the client had suffered a herniated disc in his low back. He had surgery and fortunately made a good recovery.

### What To Do If You Are In An Accident

- Immediately call the police and request that they come to the scene and prepare a traffic collision report. Sometimes the other party does not want to do this; do not let them convince you not to. This is very important.
- Call the paramedics or other emergency personnel so that you can receive prompt medical attention.
- Write down the other driver's information including name, address, phone number, date of birth and driver's license number. Also, make sure to write down the other driver's insurance information including policy number, company name and phone number.
- Write down the other driver's vehicle information including license plate, year, make and model.
- Write down any and all information from any witnesses to the accident. Make sure to include their names, addresses, phone numbers and e-mail addresses.



- Photograph the scene of the accident, including damage to all vehicles in the accident, skid marks on the road, debris and other visible evidence. If at all possible take pictures of the vehicles at their points of rest before they are moved.
- Do not give any statements to any insurance company until you have first spoken to us. The insurance company is not your friend and will try and obtain any information they can to damage your case.
- Do not sign any papers from any insurance company unless and until you have consulted with our office.

# Worker's Compensation versus Third Party

Many people think that if they are injured while they are on the job they only have a Worker's Compensation case. However, under many circumstances there might also be a third party case against another defendant. This can happen in a number of situations. The following are just a few examples:

- A truck driver or delivery person that is injured when they are driving in the course of their employment and another driver causes an auto accident. Under these circumstances the injured worker would have both a Worker's Compensation case, because the injury occurred while they were working, and also a third party case against the negligent driver that caused the accident.
- 2. A person that works on a machine at work and that machine malfunctions and causes an injury. The worker would have both a Worker's Compensation case and a Product Liability case against the manufacturer and possibly the distributor of the machine.
- 3. A person that is working on property like a ranch, home, market or hotel that is owned by someone other than his or her employer may have a case against the owner if that person does something that makes the property dangerous and causes an injury.

Many times a third party case can have a higher value than a Worker's Compensation case. If you are at all unsure it is very important to seek legal advice to make sure that you are not missing an important right.
